**Note to Parents/Guardians:** The Organising Committee of the BISRA GaddinAbtGarnish 2025.2 swim is happy to encourage younger swimmers to take part in open-water swimming events. However, there are risks for all swimmers associated with this activity, including exposure to infection and the effects of immersion in cold water. These risks are increased for younger swimmers. If you are unsure about the health of your child, either before or after participation in an open-water swimming event, you should consult your GP for advice or treatment. All swimmers must be at least 12 years of age on 23<sup>rd</sup> August 2025
